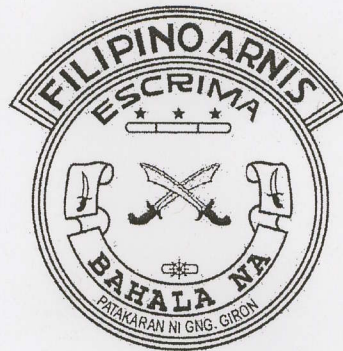

STARS UNDERNEATH REPRESENTING THE THREE PARTS OF THE PHILLIPINES (NORTHERN, CENTRAL, SOUTHERN) AND A RATTAN STICK UNDER THAT WITH TWO SWORDS CROSSED IN IN THE CENTER AND A SMALL CIRCLE WITH DIAGONAL LINES THROUGH IT AND AN ELIPSIS AROUND IT BELOW THE CROSSED SWORDS AND A BANNER CONTAINING THE WORDS "BAHALA NA" BELOW THAT WITH TWO DAGGERS ON THE ENDS OF THE BANNER AN ON THE BOTTOM OF THE CIRCLE THE WORDS "PATAKARAN NI GNG. GIRON".

THE ENGLISH TRANSLATION OF "FILIPINO ARNIS ESCRIMA BAHALA NA PATAKARAN NI GNG GIRON" IN THE MARK IS "THE FILIPINO MARTIAL ART OF HAND COMBAT AND ITS PHILOSOPHY, COME WHAT MAY, CREATED BY MR. GIRON."
